**2. Ir. Endang Noerhartati, MP.**

The Vice Rector of Relationship, Cooperation and Development Universitas Wijaya Kusuma Surabaya on Jl. Dukuh Kupang XXV No.54, Dukuh Kupang, Kec. Dukuh Pakis, Kota Surabaya, acting for and on the behalf of the Universitas Wijaya Kusuma Surabaya, herein as the SECOND PARTY.

The two parties hereby agree to hold academic mutual cooperation to promote the quality of lecturers and students with the following terms/conditions:

## Article 1

### THE OBJECTIVES

- 2) Conducting joint-research with scientific writing publications.

## Article 2

### THE SCOPES

- 1) THE FIRST and THE SECOND PARTY, with their roles and authority as already mentioned, provide each party with the opportunities to hold visiting lectures and to conduct joint-research.
- 2) THE FIRST PARTY provides the opportunities to the SECOND PARTY to send the academic teaching staff to academic activities.

THE FUNDING

The funding to reaching the objectives as mentioned in Article 2 of this agreement becomes the responsibilities of each party in accordance with the agreement.

Article 4

THE ACTIVITY REFERENCE

This Memorandum of Agreement (MoA) is the reference or the basis for the respective activities as stated in Article 2.

- 1) This agreement is not a restriction of each party to build other cooperation with other parties;
- 2) Other issues beyond the scopes of this agreement shall be taken into account later by both parties;
- 3) This Memorandum of Agreement (MoA) is valid and take effect when duly signed by both parties until the activities completed, and subject to change under the agreement of both parties.
