**CHAPTER I  
PURPOSE AND SCOPE**

**ARTICLE 1  
PURPOSE**

The purpose of this Agreement is as the guideline of partnership to give opportunity to SECOND PARTY to participate in the JBFEM Award & Symposium 2018 Singapore as a Co-Host.

**ARTICLE 2  
SCOPE**

Scope of Agreement is the organizing of the JBFEM Award & Symposium 2018 which will take place in Singapore. Visa arrangement is excluded from this agreement or the FIRST PARTY does not provide visa arrangement.

**CHAPTER II**  
**RIGHTS AND OBLIGATIONS**

**ARTICLE 3**

**OBLIGATIONS OF THE FIRST PARTY**

- (1) Organizing the JBFEM Award & Symposium 2018 which will take place in Singapore, on August 2 – 3, 2018.
- (2) Presenting UWKS logo in SSBRN media.
- (3) Presenting UWKS logo in the certificate of participants and reviewers.
- (4) Issuing Co-Host Certificate for UWKS.
- (5) Providing free registration fee for four presenters for UWKS.

**ARTICLE 4**

**RIGHTS OF THE FIRST PARTY**

- (1) Receiving one to four articles from the SECOND PARTY under Co-Host Program.
- (2) Receiving payment of Rp. 18.000.000,00 (Eighteen million rupiahs) from the SECOND PARTY based on Co-Host Program.

**ARTICLE 5**

**OBLIGATIONS OF THE SECOND PARTY**

- (1) Registering four participants to the FIRST PARTY under Co-Host Program without registration fee.
- (2) Transferring Rp. 18.000.000,00 (Eighteen million rupiahs) to the FIRST PARTY based on Co-Host Program.

**ARTICLE 6**

**RIGHTS OF THE SECOND PARTY**

- (1) Attending the JBFEM Award & Symposium 2018 which will take place in Singapore, on August 2 – 3, 2018 without registration fee for four participants.
- (2) Receiving a certificate as a Co-Host
- (3) UWKS logo is presented in SSBRN media
- (4) UWKS logo is presented in the certificate of participants.

**CHAPTER III**

**DURATION**

**ARTICLE 7**

This Agreement is valid from the date of this agreement signed until August 3<sup>rd</sup>, 2018 and may be extended within the same period by the PARTIES.



**CHAPTER IV  
OTHER PROVISIONS**

**ARTICLE 8**

**DISPUTE**

Disputes that may arise in this Agreement will be held by way of deliberation to reach consensus of the PARTIES.

**ARTICLE 9**

**FORCE MAJEURE**

In the event of any circumstances beyond the control of the PARTIES or the Force Majeure which results in the non-performance of the contents of this Agreement, the PARTIES in good faith and for the purposes of this Agreement, agree to settle by way of deliberation to reach a consensus and do not harm to each other PARTIES.

**CHAPTER V**

**CLOSING**

This Agreement is executed and signed in Singapore, on Thursday, August 2<sup>nd</sup>, 2018, in 2 (two) copies and each party owns and serves as valid evidence.
